

## DIRECTIONS FOR USE

**APPLICATION RESTRICTIONS:** Do not apply in wet, windy conditions.  
Application lasts 60-90 days under normal weather conditions.

**CORRECT USAGE:** 32 oz. of BioDefend® yields 2 gallons when mixed with water which covers and protects an area 4000 square feet. Use your favorite garden sprayer to apply. Shake well before each use. Spray area to be protected from all angles until completely wet all over. Re-apply as new growth occurs. Re-apply due to weather conditions as needed. Keep sprayer clean after use to prevent clogging. Always test product on a small area to be sure BioDefend® will not damage plants. **NOT FOR INDOOR USE.**

**PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS.** Caution: Avoid eye, skin, and clothing contact. Causes eye irritation. Wash thoroughly with soap and water after each application.

**FIRST AID:** Call a poison control center or doctor for treatment advice. Have the product container or label with you when calling a poison control center or doctor, or going for treatment. You may also contact 1-800-858-7378 for emergency medical treatment information.

**If in eyes**

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.

- Have a person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by the poison control center or doctor.
- Do not give anything by mouth to an unconscious person.

**If on skin or clothing**

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15-20 minutes.

**If inhaled**

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.
