## 2. HAZARDS IDENTIFICATION SUMMARY

## 4. FIRST AID MEASURES

## 5. FIRE FIGHTING MEASURES

**FLAMMABLE LIMITS (LFL & UFL):** Not established  
**EXTINGUISHING MEDIA:** Water fog, alcohol foam, carbon dioxide, dry chemical, or halogenated agents.  
**HAZARDOUS COMBUSTION PRODUCTS:** Carbon dioxide, carbon monoxide, hydrogen chloride, nitrogen dioxide, and sulfur dioxide.  
**SPECIAL FIRE FIGHTING PROCEDURES:** Wear self-contained breathing apparatus with full protective clothing. Fight fire from upwind and keep all non-essential personnel out of area.

## 6. ACCIDENTAL RELEASE MEASURES

### STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

For small spills, absorb with an absorbent material such as sand, vermiculite or other absorbent material. Place contaminated material in appropriate containers for proper disposal. For large spills: dike large spills using absorbent or impervious material such as clay or sand. Recover and contain as much free liquid as possible for reuse. Allow absorbed material to solidify, and scrape up for disposal. After removal, scrub the area with detergent and water and flush contaminated area thoroughly with water.

**CAUTION:** Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

**7. HANDLING AND STORAGE**

**HANDLING:** Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**STORAGE:** Keep container tightly closed when not in use. Do not store near seeds, fertilizer, or foodstuffs. Can be stored at temperatures as low as -30°F / -34.4°C. Do not contaminate water, food, or feed by storage or disposal.

**Personal Protective Equipment (PPE): Applicators and other handlers must wear:** coveralls over long sleeved shirt and long pants, chemical-resistant gloves, chemical-resistant footwear plus socks, protective eyewear, chemical-resistant headgear (if overhead exposure), and a chemical-resistant apron when cleaning equipment, mixing, or loading. Discard clothing and other absorbent materials that have been drenched or heavily contaminated with this product's concentrate. Do not reuse them. **12. ECOLOGICAL INFORMATION**

This pesticide is toxic to fish and aquatic invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not apply when weather conditions favor drift from treated areas. Runoff and drift from treated areas may be hazardous to aquatic organisms in neighboring areas.
