

DIRECTIONS FOR USE

APPLICATION RESTRICTIONS: Do not apply in wet, windy conditions.

CORRECT USAGE: Sprinkle granules directly from container. Apply a border zone around the item to be protected. Repeat as necessary until animal habit is broken. 8 ounces of BioDefend™ covers and protects an area 40 square feet. **NOT FOR INDOOR USE.**

PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS. Caution: Avoid eye, skin, and clothing contact. Causes eye irritation. Wash thoroughly with soap and water after each application.

FIRST AID: Call a poison control center or doctor for treatment advice. Have the product container or label with you when calling a poison control center or doctor, or going for treatment. You may also contact 1-800-858-7378 for emergency medical treatment information.

If in eyes

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

If swallowed

- Call a poison control center or doctor immediately for treatment advice.
- Have a person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by the poison control center or doctor.
- Do not give anything by mouth to an unconscious person.

If on skin or clothing

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15-20 minutes.

If inhaled

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.
