

DIRECTIONS FOR USE

APPLICATION RESTRICTIONS: Do not apply in wet, windy conditions.

Application lasts 60-90 days under normal weather conditions.

CORRECT USAGE: Shake well before each use. Spray item to be protected from all angles until completely wet all over. Re-apply as new growth occurs. Re-apply due to weather conditions as needed. Keep sprayer clean after use to prevent clogging. 32 oz. of BioDefend™ covers and protects an area 500 square feet. Always test product on a small area to be sure BioDefend™ will not damage plants. **NOT FOR INDOOR USE.**

PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS. Caution: Avoid eye, skin, and clothing contact. Causes eye irritation. Wash thoroughly with soap and water after each application.

If in eyes

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.

If swallowed

- Call a poison control center or doctor immediately for treatment advice.
- Have a person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by the poison control center or doctor.
- Do not give anything by mouth to an unconscious person.

If on skin or clothing

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15-20 minutes.

If inhaled

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.
